## CIRCULAR DATED 06.10.2023

To All the Members of HCA

1. As per the Election Schedule already communicated, the issue and receipt of Nominations at HCA Registered Office, RGICS, Uppal, Hyderabad will be on the following days.

- i. 11.10.2023 (Wednesday)
- ii. 12.10.2023 (Thursday)
- iii. 13.10.2023 (Friday)

2. The electoral roll of eligible full members of HCA to participate in the electors as approved & furnished by the SMC appointed by Hon'ble Supreme Court of India was already displayed on HCA notice board & Website for receipt of requests for changes in the authorized representations if required.

Accordingly, all the requests received upto 5:00pm on 7.10.2023 were considered and all genuine requests were taken into consideration and the electoral roll with authorized representatives was duly updated and displayed on the HCA Notice Board and website.

3. Electoral Officer, HCA calls upon the representatives of eligible full members to file nomination papers for election to the posts of:

- a) President
- b) Vice President
- c) Secretary
- d) Joint Secretary
- e) Treasurer
- f) Councilor

Nomination forms can be had from the office of HCA during office hours by authorized representatives of eligible full members.

4. For filing of nomination, the contesting candidate has to use separate Nomination Form for each post of Office Bearer / Councilor. A contesting candidate is permitted to file separate nomination forms for more than one post, but he has to limit his contest to only one post, after scrutiny. It is made clear that a candidate can contest for only one post in the election and if he fails to withdraw from the other posts, his nominations for all the posts will be treated as invalid. The contesting candidate has to produce proof of date of birth preferably Aadhar Card or Secondary School Certificate (SSC). The candidate is also required to submit two passport size photographs along with nomination forms.

5. The contesting candidate has to submit the Nomination form between 11:00 AM and 3:00p.m. on the days appointed for receipt of nomination forms and the affidavit on the nomination form must be attested by a Notary. Nomination form shall be submitted by the candidate himself personally and in case of unavoidable circumstances, by the proposer or seconder, with due authorization from the candidate.
