- The HCA Elections for Officer Bearers is fixed for 20.10.2023. As part of the Electoral process the Electoral Roll containing names of the member Clubs / Institutions / International Cricketers as approved by the Single Member Committee appointed by Hon'ble Supreme Court was published on 30.09.2023. The Member Clubs/Institutions were given an opportunity to seek change of representatives, if required, by following the procedure indicated, before 7<sup>th</sup> of October, 2023.
- 2. A.P. High Court is one of the institutional members. The President of Telangana State High Court Advocates Association had sent a letter dated 21.09.2023 informing that one Mr. K. Sunil Goud, Vice Chairman, Telangana High Court Bar Council be made their representative for the forthcoming HCA elections. As Telangana State High Court Advocates Association being Successor agency of A.P. High Court Advocates Association, the said request was accepted and the name of Sri K. Rajeshwar Rao which was existing at the time of draft roll was replaced by Sri K. Sunil Goud as requested by Telangana State High Court

Advocates Association. Sri K. Rajeshwar Rao has represented vide his letter dated 09.10.2023 that he has been associated with the club for over a decade and requested to restore him as representative in the voter list. In the meantime, Telangana State High Court Advocates Association has sent another communication dated 10.10.2023 in which they have stated

"It is further stated that inadvertently we wrote a letter on 21.09.2023 recommending and nominating name of Sri K. Sunil Goud, Advocate on behalf of our Association. In view of the complaints / requests from the learned members, we hereby withdraw the letter dated 21.09.2023"

- 3. In the circumstances as nomination of Sri K. Sunil Goud has been withdrawn by the Telangana State High Court, Advocates Association, in order to enable the institutional club to exercise its voting rights, it is ordered to restore Sri K.Rajeshwara Rao, as representative of the institutional club, A.P. High Court/Telangana High Court.
- The above orders are issued under the powers vested in me as Electoral Officer under Rule 33 of the Memorandum of Association and Rules and Regulations – 2018.
