Sub: GHMC Cricket Teams illegal transfer of 18 No's Cricket Teams from GHMC to unauthorized private persons -initiation of enquiry by ACB-Request to suspend the clubs which are unauthorizedly transferred to private persons and deprived of any voting rights-Reg.

With reference to the above cited subject it is to inform that the Director, Enforcement Vigilance and Disaster Management, GHMC, Hyderabad, informed vide letters cited in reference 1,2 &4 that originally 21 No's of Cricket Teams were registered and representing from GHMC in the leagues conducted by the HCA. But currently only 3 teams are representing from GHMC in the leagues conducted by the HCA with club names as 1. GHMC Employees team, 2. Red Hills Play Ground Team and 3. Saleem Nagar Play Ground Team. It is reported that remaining 18 No's teams have been illegally transferred from GHMC to unauthorized private persons without bringing to the notice and approval of the Commissioner of GHMC. It is also reported that some unscrupulous members of HCA colluding with some corrupt officers in GHMC have illegally transferred 18 No's Cricket Teams to unauthorized private persons. There must be huge unlawful money transfer and other unethical gains involved in such illegal transfer of teams. The illegal transfer of teams from GHMC also lead to award of voting right to inappropriate private persons.

The GHMC Commissioner also addressed vide reference No.5 stating that in the year 2016 Sri Asaduddin Owaisi, Hon'ble Member of Parliament has informed that the Cricket Teams which are under the Municipal Corporation Hyderabad have been illegally and unlawfully transferred by the then Director of Sports, Municipal Corporation, Hyderabad to private individuals. The then officer on Special Duty (Sports), GHMC as requested the Secretary Hyderabad Cricket Association to furnish the remarks on the illegal transfer of Cricket Teams. But there is no response from the HCA in this regard.

Further the Director, EV&DM/GHMC, Hyderabad vide ref. No. 1 & 2 has informed the same thing to the HCA and requested the President HCA to revert back the illegal transfer 18 No's Cricket Teams from the unauthorized private persons and handover to legitimate owner i.e. GHMC. But nothing heard from the HCA.

On the basis of letter cited in reference 4, the Anti-Corruption Bureau as taken up an enquiry in to the allegations of corruption of Govt. Employees as well as HCA officials in the unauthorized transfer of GHMC Clubs to private individuals. In view of the ongoing ACB enquiry these 18 No's clubs mentioned above which were transferred unauthorizedly to private persons from GHMC must be kept under suspension and deprived of any voting rights till completion of the enquiry by ACB.

Therefore, necessary action may be taken at your end.
