CORRIGENDUM: To the Official Consolidated Notification dated 04/04/2026

This is to inform all concerned clubs, institutions, and stakeholders that the Official Consolidated Notification dated 04th April 2026 stands modified to the extent mentioned below. All other terms and conditions shall remain unchanged.

1. Amendment to Point No. 4 (e): Team Composition Requirement – A division clubs.

The provisions relating to team composition under Point No. 4 (e) shall not be applicable to Combined District Teams and Institutional Teams.

2. Amendment to Point No. 6 (f): Transfer of Players Guidelines.

Teams shall be permitted to transfer a maximum of two (2) players to a higher division team, such transfers shall be allowed for a maximum of two (2) matches per tournament during the season.

3. Amendment to Point No. 11 (i): Club Secretary Responsibilities.

All players must participate strictly under their true and registered identity as submitted to HCA. In the event a player is found, at any stage during a match, to be participating under a false identity. The player shall be immediately suspended from the match. The concerned team shall continue the match with the remaining eligible players. No replacement shall be permitted for the suspended player for that match. Any complaint pertaining to a player's registration, eligibility, or documentation shall be submitted in writing, duly signed, by the Club Secretary or the Captain of the opposing team.

4. Amendment to Point No. 12 (a) (i, ii, iii, iv): Discrepancy / Document Irregularity Policy.

- i. Interim Action: Upon receipt of a complaint and prima facie satisfaction. The concerned player shall be immediately suspended pending inquiry.
- ii. Continuation of Match: The match shall proceed with the remaining eligible players. The result and allocation of points shall remain provisional, subject to inquiry outcome.
- iii. Finalization of Result: The official result and points shall be confirmed only after conclusion of the inquiry by the competent authority.
- iv. Finding of Guilt: If the player is found guilty. The match shall be awarded to the opposing team. The player shall be banned from participating in HCA leagues for a period of two (2) years.

- v. Finding of No Fault: If the player is found not guilty or not at fault, the result of the match shall remain unchanged and stand as originally recorded.
- vi. False or Malicious Complaint: If a complaint is found to be false or malicious. The team lodging such complaint shall be penalized with deduction of five (5) points from its standings in the points table.

5. Amendment to Point No. 14 (g)

Point No. 14 (g) stands relaxed as per the relevant notification issued separately.

Note: This Corrigendum shall be read as an integral part of the Official Consolidated Notification dated 04/04/2026 and shall come into effect immediately.
