The Writ Petitioner Cricket Club had prayed before the Hon'ble High Court of Telangana to suspend the operation of the Order of the 2nd Respondent (Single Member Committee headed by Justice L.Nageshwara Rao, Hyderabad Cricket Association) dated 31.07.2023 in so far as barring all the existing Executive Committee Members of the Petitioner Club from holding office and / or contesting the elections in the 1st Respondent Association (The Hyderabad Cricket Association) for the next one term or for three (3) years of the Executive Committee whichever is greater by permitting the Executive Members of the Petitioner Club to vote and contest in the forth-coming elections to the Hyderabad Cricket Association pending disposal of writ petition.

The Hon'ble High Court of Telangana after hearing the Advocates of the concerned parties deemed "it appropriate to direct the Respondent No.3 (The Electoral Officer, HCA) to consider the representation dated 14.08.2023 submitted by the Petitioner and examine the same in accordance with Rule 33(3) of the Hyderabad Cricket Association, Rules and Regulations, 2018 and pass appropriate orders and communicate the decision thereon to the Petitioner."

Accordingly Sri D.Narsing Rao, Secretary of Saint Sai Cricket Club has also submitted a representation on 06.09.2023.

In the interregnum, the Hon'ble Supreme Court of India became seized of the matter and passed the following order in I.A. No.183293/2023 dated 15.09.2023.

"It appears that contrary to the intent of our order to put an end to the mess which was going on, in the process of working of the Single Member Committee and in appointing one Mr. Sampath Kumar to assist him in the election process, various parties have been approaching the High Court and seeking different orders. Some proceedings have also been filed before the District Courts.

In our view, no such proceedings could have been initiated at all and if they have any grievance, the only remedy lays before this court.

The result of the aforesaid is that we restrain the High Court and the District Courts from passing any order qua the working of the Single Member Committee and if orders have been passed, the same will not be given effect to."

In the Light of the above Order/Directions of the Hon'ble Supreme Court, the representations dated 14.08.2023 and 06.09.2023 do not survive and accordingly the representations stand disposed of.
